Hon. Darrell Steinberg and Hon. Dave Jones to Speak at HTSCC 2011 Investor Briefing on April 8, 2011

Hon. Darrell Steinberg, President pro Tem, California State Senate and California State Insurance Commissioner Dave Jones will be speaking at the April 8th 2011 HTSCC Investor Briefing event to be held at the Oshman Family JCC in Palo Alto.

Senator Steinberg (D-Sacramento) accepted Housing CA's "Public Service and Leadership" award on April 27, 2009, proclaiming that "Homelessness does not have to be hopelessness." Referencing his bill, SB 500, which would create permanent state investment in affordable-home programs, Senator Steinberg promised, "We will get this done." Senator Steinberg has been a staunch advocate for finding a permanent source of funding for affordable housing.

Dave Jones served in the California State Assembly from 2004 through 2010, where he chaired the Assembly Health Committee, the Assembly Judiciary Committee and the Budget Subcommittee on Health and Human Services. Named "Consumer Champion" by the California Consumer Federation in 2008, Jones also was awarded the "Leadership Award" by the Western Center on Law and Poverty. Planned Parenthood, Environment California, the Urban League, Preschool California and CalPIRG have honored his work.

The Housing Trust will be honoring Charities Housing, the City of Santa Clara and Bank of America for their commitment to moving people from homelessness to permanent housing and for their assistance in seeing that homeownership is a reality for so many.
